The facts briefly stated are as follows:

On 20 Oct 16, at the George N. Leighton Criminal Courts Building, Offender Sierra Traylor engaged in a verbal argument with Deputy [REDACTED] behind Central Bond Court. As Deputy [REDACTED] attempted to handcuff Traylor behind her back, she pulled away while flailing her body. Offender Traylor had to be taken to the ground. Deputy [REDACTED] along with assistance from Deputy [REDACTED] attempted to handcuff her. Offender Traylor was kicking and spitting at the Deputies. Offender Traylor kicked Deputy/Victim [REDACTED] to the left side of her face causing her head to strike the wall. As Traylor was being escorted to the lockup area, Traylor bit Deputy/Victim [REDACTED] in his upper right arm. Traylor then spat onto Deputy/Victim [REDACTED] left arm. Traylor was placed onto a bench in the lockup. Deputy [REDACTED] placed a spit mask onto Traylor's head and Traylor was secured to a bench. Deputy [REDACTED] and Deputy [REDACTED] were taken to Mt. Sinai Hospital via ambulance for a medical evaluation. Deputy [REDACTED] sustained an injury to her head and Deputy [REDACTED] was treated for a bite wound to his upper right arm.
